### Dear All:

Berg & Androphy represents Dr. O.H. "Bud" Frazier. This letter is a demand that the *Houston Chronicle* and *ProPublica* retract their May 24, 2018 article about Dr. Frazier, which ran under the vicious headline, "A Pioneering Surgeon's Secret History of Research Violations, Conflicts of Interest and Poor Results" (the "2018 Article"). To be clear, you must run the retraction with corrections and an apology, and, as Texas law requires, in the same space that the 2018 Article ran in both *ProPublica* and the *Houston Chronicle*.

I have also attached the lawsuit Dr. Frazier filed today in Harris County District Court, naming as defendants the *Houston Chronicle*, *ProPublica*, Charles Ornstein and Michael Hixenbaugh. I hope you read it carefully and take it seriously: it chronicles in great detail Hixenbaugh's and Ornstein's extraordinarily feckless reporting, especially its many inaccuracies.
